

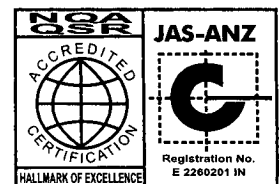


**NOTES :**

1. Segment wise reporting as required in IND AS 108 is not applicable as the Company has only one segment.
2. The management is taking various steps to reduce costs, improve efficiencies to make its operations profitable and to arrange sufficient funds for its operations. In view of these, financial statements have been prepared on the basis that the Company will continue as a "going concern".
3. The financial statement does not include IND AS compliant results for preceeding quarter and previous year ended March 31, 2017 as the same is not mandatory as per SEBI circular CIR/CFD/FAC/62/2016 dated July 05, 2016.
4. The above results have been reviewed by the Audit Committee and approved by the Board of Directors in its meeting held on August 04, 2017 in terms of Regulation 33 of SEBI (Listing Obligations and Disclosure Requirments) Regulations, 2015.
5. The Statutory Auditors have carried out "Limited Review" of the above financial results.
6. These financial statements are company's first IND AS Financial Statements. The Company has adopted IND AS Standards effective from April 01, 2017 with comparatives being restated and the adoptions were carried out in accordance with IND AS 101 - First time adoption of Indian Accounting Standards. All applicable IND AS have been applied consistantly and retrospectively, wherever required.
7. The Unaudited Financial Results for the corresponding quarter ended June 30, 2016, prepared under IND AS, is not subject to Limited Review by the Statutory Auditors of the Company and is as prepared by the management. The management has exrecised necessary due diligence to ensure that financial results provide a true and fair view of its results for that period.

**INDEPENDENT AUDITOR'S REVIEW REPORT**

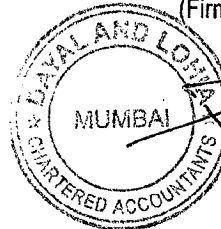
